HONESTY AND INTEGRITY

All donations are the property of The Salvation Army. Failure to comply with this will result in your immediate removal from the Kettle Campaign.

IMPORTANT NOTE: THE USE OF ALCOHOL OR NON-PRESCRIPTION DRUGS WHILE ON DUTY OR SHOWING UP FOR DUTY UNDER THE INFLUENCE IS STRICTLY PROHIBITED.
